AGENDA ITEM 3. EXECUTIVE DIRECTOR'S REPORT

Mr. Miller reported the Black Creek Reservoir has 5.7 foot of sediment that has settled in our reservoir since 2009. Mr. Miller is trying to schedule a site visit with DEQ to get the dredging project started.

Mr. Miller reported that Wintergreen Resort has put in a place a voluntary water restriction starting September 3rd due to the lack of rainfall and Lake Monacan being close to 40" low. The voluntary water restriction includes sending out a notice from NCSA to all customers asking them to exercise voluntary water conservation, including reducing and/or stopping all "Outside Water" use. The notice was send by WPOA on behalf of the Nelson County Service Authority to the Wintergreen customers. The Service Authority performed leak detection and has repaired several water leaks in the distribution system.

Mr. Miller discussed a letter received by email from Mr. Steve Carter, County Administrator on September 17, 2019, in reference to the transfer of ownership of the Piney River system to the Nelson County Service Authority. Mr. Miller also provided a list of differences in current rates and operational concerns. It was suggested that Mr. Miller meet with Mr. Steve Carter in reference to the letter and his concerns.
